1. TRADITIONAL : written in all capital letters with a condensed, sans -serif font, placed above the central text.
2. ETKU: the most prominent part of logo, written in large, bold, uppercase letters, suggesting strength and impact.
3. KARATE 91: Positioned below ETKU in a slightly smaller bold font, still in all caps, giving additional context and indicating the year of establishment.

ETKU has to be register in Berlin.
